



Before travelling to Argentina, delegates from the three countries mentioned above must go to www.virtual.provinciapagos.com.ar/ArgentineTaxes/ and pay the Reciprocity Fee. The site will then generate an e-receipt, which **MUST** be printed and presented as proof of payment on arrival in Argentina. Failure to provide proof of payment will result in denied entry and return to the passenger's point of departure. Please note that this is a requirement of the Ministry of the Interior of Argentina.

Transfer and transport between the airport and the city centre

Buenos Aires has two airports:

International Airport Ministro Pistarini - Ezeiza, 35 km from the city and Jorge Newbery domestic airport – Aeroparque, located in town, in Palermo quarter. As soon as you go out from the customs at the Ezeiza Airport or right in the luggage pick up area, there are several cab companies which offer transfers (Manuel Tienda León, Transfer Express and Universo). Credit cards are accepted. Closer to the Congress' dates, the OC will send an email with information about the fares charged by each of those companies).

Tipping in taxis, restaurants and hotels is not mandatory, but tipping for good service is appreciated, currently 10%.

From 10:00 to 20:00. Shopping malls: 10:00 to 22:00

Sanitary information

No special measures must be taken for travelling to Buenos Aires and to the main tourist destinations in Argentina. Check with your physician for appropriate advice if you plan on visiting other places in South America. The public water supply is reliable.

Safety

Buenos Aires is one of the safest cities in Latin America and Puerto Madero, where the Congress Hotel is located, is the safest area in the town. However, as in any large city, it is advisable to be cautious, particularly in crowded tourist destinations such as San Telmo and La Boca, where pickpockets may operate. Traffic is busy in Buenos Aires. Take extra care when crossing streets.


