1. Past events 2017

A short recap of the last 12 months commission events was made; The annual labour and immigration law seminar with “hot topics” took place in October in Bratislava together with the TRADE commission. Our commission was also involved in the scientific program on AI at the annual congress in Tokyo.

2. Events 2018 (Brussels, Turin)

Matteo Cocuzza, Nicky de Groot and Rebekka Strumpfrock in the Organization Committee for the annual labour law and immigration law seminar 4-6 October 2018 in Turin gave a presentation of the upcoming program. The seminar is a joint seminar together with the M&A commission. It was noted that as an alternative to fly in to Turin, the airport of Milano can be used.
