Pursuant to Belgian Royal Decree on 9 April 2020 as amended by Art. 2 of the Belgian Royal Decree on 28 April 2020, the General Assembly will entirely be held online.

Each Member will receive the link to the streaming platform where will be allowed to follow the General Assembly and the one to access the electronic voting platform: the electronic voting system and the streaming will enable all Members around the globe and in different time zones to remotely participate to the meeting and personally cast their votes.

In accordance with Art. 23(4)(a) of our by-laws, the voting process will take place as follows:

- from Thursday, August 27<sup>th</sup>, 2020 at 9:30 CET until Friday, August 28<sup>th</sup> at 15:30 CET you will be allowed to vote for the candidates to the position of First Vice President, and of Secretary General, as well as for the partial renewal of the Executive Committee, and
- on Friday August 28<sup>th</sup>, from 15:00 to 15:30 CET you will be allowed to vote on all the other Resolutions proposed by the Bureau to the General Assembly.

Please consider that, since the election for the vacant positions to the EC meeting and to the Secretary General will be possible as of Thursday, August 27<sup>th</sup>, 2020, purusuant to Art. 23 (6) of our by-laws, **the deadline for submitting the candidacies is Tuesday August**, 25<sup>th</sup>, 2020 at 18:00 CET.

If Members are unable to personally cast their vote or prefer to appoint another Member as proxy holder, they are invited to fill in the dedicated proxy form available on the Section "MyAija" of the website (www.aija.org).

In accordance to Art. 22(4) of our by-laws, in order to be valid, proxies shall be assigned via the electronic proxy system **no later than Tuesday, August 18th, 2020 at 23:59 CET**; proxies are irrevocable and, once assigned, the Member will not be able to use his/her own vote anymore, during the entire election process.

In accordance to Art. 22(5) of our by-laws, an individual member may not vote by proxy for more than twenty-five other individual members; in any case, only Members eligible to
