4. Tokyo 2017 Insolvency Law Commission session

The President set out the status of the preparation for the Insolvency Law session in Tokyo. He explained that at the Forum of the Commission Meeting the decision was made to merge the session with those of the Corporate and M&A Commission and the Intellectual Property, Technology, Media and Telecommunications Commission, resulting in a four hour morning session. The President presented to the participants the idea of an Annual Insolvency Conference, in line with the activities of other Commissions that organize a yearly activity. As to timing, it seems most feasible to aim for a first conference in 2018. The participants welcomed the idea.

8. Other plans for 2017

Giuseppe Scotti presented the event he is organizing in Parma end of April 2017. The topic will be Non-performing Loans, with contributions on real estate, tax and insolvency. Participants are invited to attend.

9. The Newsletter

The Vice-President explained to the participants that the newsletter is instated to create a form of communication from the Insolvency Law Commission to the members. Participating in the newsletter will be highly appreciated and (scientific) content is welcomed.
